Daycare & Boarding Agreement

Pawsitively Purrfect wants you to know our primary focus is on the safety and well-being of your pet(s) is of the highest importance. We pride ourselves on a safe, fun, and enjoyable experience for your furry friend.

We encourage you to ask our receptionist lots of questions, and get clarification on any policy you may have questions on.

Please read and agree to our terms of service below before your pet can join our daycare:

- ✓ Pet Parent declares their pet(s) have been vaccinated by a licensed veterinarian and the records presented to Pawsitively Purrfect are up to date on DHLPP, Rabies, and Bordetella (must be every 6 months).
- ✓ Pet Parent understands that even though all pets are properly vaccinated in the facility, a medical situation could arise due to the communal group of pets, in which Pet Parents will be responsible for any and all medical costs.
- ✓ Pet Parent agrees to have not held back any information from Pawsitively Purrfect staff and/or temperament evaluator as to whether their pet(s) have ever been in a pet fight or bitten another animal or person whether it was at their home, on a walk, pet park, different boarding, or daycare facility, etc.
- ✓ Pet Parent agrees to the socialization of their pet(s) while under the care of Pawsitively Purrfect.
- ✓ Pet Parent agrees their pet(s) shall not leave the facility until all charges due are paid in full.
- ✓ Pet Parent agrees that any pet(s) dropped off prior to 1:00pm or picked up after 12:00pm will void our half day fee and be charged for a full-day stay at the discretion of management.
- ✓ Pet Parent agrees any return check will result in a \$25.00 fee in addition to any financial institutions fees. Future payments will be subject to prepayments via cash or credit card.
- ✓ Pet Parent agrees that if any external parasites are found during services, pets will be treated and isolated from daycare for the remaining length of stay.
- ✓ Pet Parent understands although sick or unvaccinated pets are not permitted to attend, placing their pet into an area in which communicable diseases may pass between seemingly healthy pets. If following a provided service date, the pet shows signs of illness, the Pet Parent may not hold Pawsitively Purrfect liable for any inadvertent exposure the pet may have contracted.
- ✓ Pet Parent understands while all pets must pass our evalve to be eligible for daycare, certain unacceptable behaviors may arise after days in daycare. If said behaviors occur, Pawsitively Purrfect reserves the right to immediately deny any pet(s) eligibility or isolate for remainder of stay at any time in the event the pet(s) shows the potential to cause severe injury or unwilling to adjust to Pawsitively Purrfect daycare program.
- ✓ Pet Parent understands if your pet(s) are denied further eligibility for any reason, you may be eligible for a refund on any remaining days on packages pre-purchased by management.
- ✓ Pet Parent understands their pet(s) may not wear their personal collars in daycare, but will be provided with a temporary collar to ensure safety in the event of a scuffle.
- ✓ Pet Parent agrees all prices are non-negotiable and subject to change without notice.
- ✓ Pet Parent understands their pet(s) must not have any conditions which can be aggravated by active play or have any contagious disease symptoms such as cough, cold, nasal discharge, etc.
- ✓ Pet Parent understands Daycare Packages may be used for multiple pet(s) but only at a full-day cost no matter if stay is only for a few hours.
- ✓ Pet Parent understands Daycare hours are 7am-6pm Monday-Friday, closed Saturday/Sunday.
- ✓ Pet Parent understands that if authorized to drop off or pick up before 7am or after 6pm, a Convenience Fee of \$25.00 for early/late arrival/departure shall be assessed to the account.

I understand that I am solely responsible for any harm caused by my pet(s) while attending daycare at Pawsitively Purrfect. I also understand and agree that in admitting my pet(s), Pawsitively Purrfect has relied upon my representation that my pet(s) is/are in good health and have not harmed or shown aggressive or threatening behavior towards any person or any other animal. I further understand that due to the way that pets interact with one another, minor cuts and scratches can occur even though the pets are always carefully supervised. While my pet(s) is/are in the care and custody of Pawsitively Purrfect, if I am unreachable in the event of an emergency, I hereby authorize Pawsitively Purrfect, its agents, and/or representatives to seek immediate veterinary care for my pet. I understand that all costs relating to veterinary, medical, or other treatment shall be my responsibility. I hereby release and agree to save and hold harmless, Pawsitively Purrfect, it's directors, officers, shareholders, employees, assistants, members, and agents from any and all liability, claims, suits, actions, loss, injury, or damage of any nature or kind, or for any liability, claims, suits, actions, loss, injury, or damage which I or my pet(s) may sustain or which may be caused in any way by my pet(s). I specifically, without limitation, agree to fully indemnify Pawsitively Purrfect for any and all such liability, claims, suits, actions, losses, injury, or damage. I certify that I have read and understand the rules and regulations set forth herein and that I have read and understand this agreement. I agree to abide by the rules and regulations and accept all the terms, conditions, and statements of this agreement and confirm the truthfulness of the contents of the Application form completed by me. Although, we carefully screen all applicants, occasionally we discover that this is not an appropriate environment for every pet. Pawsitively Purrfect reserves the right to permanently remove a pet from daycare at any time. In addition, Pawsitively Purrfect reserves the right to disallow certain breeds to participate in the daycare.
